UPGRADING OF THE ONE (1) KILOWATT INTO TEN (10) KILOWATTS OF ZAMBOANGA STATE COLLEGE OF MARINE SCIENCES & TECHNOLOGY (ZSCMST) – PHILIPPINE BROADCASTING SERVICE (PBS) MARINO NEWS FM BROADCAST TRANSMITTER

1. The Zamboanga State College of Marine Sciences and Technology, through the GAA FY 2023 intends to apply the sum of Eleven Million Pesos (Php 11,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the Contract for B-035-2023. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.

2. The Zamboanga State College of Marine Sciences and Technology now calls for the submission of eligibility documents for the UPGRADING OF THE ONE (1) KILOWATT INTO TEN (10) KILOWATTS OF ZAMBOANGA STATE COLLEGE OF MARINE SCIENCES & TECHNOLOGY (ZSCMST) – PHILIPPINE BROADCASTING SERVICE (PBS) MARINO NEWS FM BROADCAST TRANSMITTER. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before May 02, 2023 within 8:00 A.M. to 5:00 P.M. at ZSCMST BAC Office G/F ITC Building Fort Pilar, Zamboanga City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

3. Interested bidders may obtain further information from ZSCMST and inspect the Bidding Documents at the address given below during standard office hours from Monday to Friday 8:00 am to 5:00 pm.

4. A complete set of Bidding Documents may be acquired by interested Bidders on April 24, 2023 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (Php 25,000.00)

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of up to five (5) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

Criteria/Metrics

Weight

Applicable experience of the consultant (meaning the consulting firm) and associates in case of joint ventures, considering both the overall experiences of the firm or, in the case of new firms, the individual experiences of the principal and key staff, including the times when employed by other consultants. 50 %

Qualification of principal and key staff of the consultant who may be assigned to the job vis-à-vis extent and complexity of the undertaking. 30%

Current workload relative to capacity 20 %

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

(i) Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

7. The Procuring Entity shall evaluate bids using the Quality Based Evaluation (QBE) procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.

8. The contract shall be completed within 120 calendar days.

9. The ZSCMST reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
